Child and family services report: September 2021

General update:

We have received enhanced funding in this service area that will extend our current work. It also enables us to begin the work of building the structures and service model to take care of our own Child Protection Jurisdiction. Preparation for Jurisdiction will take several years. When we are ready, we will engage the federal government in negotiations for Jurisdiction. This is likely about five or so years away.

- 1) We received a grant that supports our three year plan to get ready for Jurisdiction negotiations. So far the funding is for year one. During year one we are collecting information about what laws need to be in place, and what policies and procedures need to be in place. Our plan includes plenty of community consultation.
- 2) We received a retroactive amount for Child Protection Prevention, based on a national court decision for communities who are NOT served by a Designated Aboriginal Agency.
 - a. Approximately \$3,000,000 was received and will go towards the construction of offices and program spaces for our Child and Family Services. We are hoping this can be co-located with the new Cultural building being planned.
- 3) We received an increase in our annual allotment under the Community Wellbeing Jurisdiction.
 - a. This will allow us to hire a Manager, Supervisor, and Coordinator that will be dedicated to Child and Family Services. These new staff will continue the great work being done. They will also do the Jurisdiction preparation work.
